Why do we collect Personal Information?

Your personal information will be treated as private and confidential. Collecting personal information assists us in various ways, including monitoring and improving our legal services and client relationships. The information is used for undertaking the transaction, action or other legal work arising from instructions received from a client.

Personal information may also be collected to assist with marketing. We may use your contact details for a variety of purposes, including but not limited to the following:
